SUBJECT: Determination Regarding Attendance by NASA employees at the Spring Fling hosted by the Armed Forces Communications and Electronics Association Bethesda Chapter on May 6, 2014

On May 6, 2014, the Armed Forces Communications and Electronics Association International (AFCEA) Bethesda Chapter, a non-profit organization under section 501(c)(3) of the Internal Revenue Code, will host its Spring Fling at the Velocity 5/Social Haus, at 2300 Clarendon Boulevard, Arlington, VA 22201, at 5:00 p.m. The event will benefit the Challenger Center for Space Science Education.

Approximately 5,000 people have been invited, including Congressional members and staff, state and local officials, academia, industry representatives, personnel from other Federal Agencies, members of the public, media, and contractors. The approximate cost of food and beverages to be served is \$25. I have determined this event meets the requirements of a "widely attended gathering" as defined in 5 C.F.R. §2635.204(g).

I further determine that there is an Agency interest in having NASA personnel attend the event because it will further Agency programs or operations by facilitating the exchange of professional information between NASA employees and representatives of other organizations, including information on NASA's policies and plans.

Accordingly, NASA employees whose duties do not substantially affect the sponsor, or a majority of its members, including NASA employees in non-career positions who are required to sign the ethics pledge under Executive Order 13490, may accept an invitation for themselves and an invited guest from AFCEA.

However, NASA employees whose duties may substantially affect the event sponsor, or a majority of its members, such as by way of procurement duties, should seek an individual determination pursuant to 5 C.F.R. § 2635.204(g)(3)(i) regarding participation in this event from their local ethics counselor.
