

## **Grant Information Circular**

**GIC 21-03** 

**February 4, 2021** 

**PURPOSE:** The purpose of this Grant Information Circular (GIC) is to inform NASA program offices, Technical Officers, and Grant Officers that the Guidebook for Proposers for the Preparation and Submission of Unsolicited Proposals (Unsolicited Guide) has been revised, and the new 2021 edition of the Unsolicited Guide is available internally on MAX.gov and will be publicly available on the Grants Policy and Compliance (GPC) Branch website. The 2021 edition of the Unsolicited Guide will be effective February 15, 2021.

**BACKGROUND:** The Unsolicited Guide outlines the policies and guidelines for the preparation of formal unsolicited proposals for those proposers that wish to convey their creative methods or approaches to NASA. It provides the foundation, framework, and procedures that NASA program offices use to carry out the award functions of planning, reviewing, and selecting proposals. The Unsolicited Guide was last updated in May 2016. Starting in 2021, on an annual basis, GPC will revise and update the Unsolicited Guide as necessary. Revisions to the Unsolicited Guide aims to clarify and enhance existing guidance, policies, and procedures. Appendix A of this GIC includes a crosswalk that outlines the major revisions to the Unsolicited Guide and their location in the Guide.

**GUIDANCE:** The policies and procedures in the Unsolicited Guide apply to all unsolicited proposals for financial assistance that would result in grants and cooperative agreements, regardless of the NASA Center or Agency program for which they are intended. NASA program offices must adhere to the Unsolicited Guide when evaluating, selecting, or declining unsolicited proposals.

**EFFECTIVE DATE:** This GIC is effective February 15, 2021.
