COMPLIANCE IS MANDATORY.

SUBJECT: Armstrong Smoking Policy

RESPONSIBLE OFFICE: Office of the Center Director

1. POLICY

- a. It is National Aeronautics and Space Administration (NASA) Armstrong Flight Research Center (AFRC, hereinafter referred to as Center) in Edwards, California, policy that the burning of tobacco products (i.e., "smoking", to include the use of electronic cigarettes, i.e., "e-cigarettes") are not allowed in:
 - (1) Center buildings or on building roofs,
 - (2) Government owned or leased vehicles,
 - (3) NASA-controlled aircraft operated by, or under the auspices of, the Center, or
 - (4) Outdoor areas within 25 feet of air intakes, doors, operable windows, and posted non-smoking areas.
 - (5) Outdoor areas within 50 feet of where smoking is prohibited for operational or safety reasons (such as where flammable materials are used or stored).
 - (a) Smoking materials and matches are to be discarded in receptacles designed for that purpose and custodians will dump the contents of smoking receptacles into containers designed for such material.

2. APPLICABILITY

- a. This directive is applicable to the Center and on-site support contractors, grant recipients, other partners to the extent specified in their contracts or agreements, and visitors.
- b. This policy includes all vapor producing devices commonly described as e-cigarettes.
- c. In this directive, all mandatory actions (i.e., requirements) are denoted by statements containing the term "shall." The term "may" denotes a discretionary privilege or permission, "can" denotes statements of possibility or capability, "should" denotes a good practice and is recommended, but not required, "will" denotes expected outcome, and "are/is" denotes descriptive material.
- d. In this directive, all document citations are assumed to be the latest version unless otherwise noted.

3. AUTHORITY

- a. Executive Order 13058, August 9, 1997, Subject: Protecting Federal Employees and the Public From Exposure to Tobacco Smoke in the Federal.

NASA-STD-8719.11, Safety Standard for Fire Protection

4. APPLICABLE DOCUMENTS AND FORMS

AFOP-8715.3-009, Fire Safety

5. RESPONSIBILITY

- a. The Center Director shall monitor adherence by the employees at the Center to this policy.
- b. The Center's Chief Medical Officer shall:
 - (1) Be the primary point-of-contact (POC) for monitoring the performance of this policy and reporting on its enactment to the Center Director.
 - (2) Guide employees who wish to quit smoking to locate self-help programs for this purpose.
- c. Supervisors shall:
 - (1) Ensure that tobacco products are not burned (smoked) inside any interior building / facility or within 25 feet of air intakes, doors, operable windows, or posted non-smoking areas.
 - (2) Permit brief breaks for employees to go outside to smoke to reasonably accommodate employees who choose to smoke.
 - (3) Assure that smoking breaks are relatively infrequent and do not detract from normal productivity and job performance.
 - (4) Enforce this policy and additional controls found in AFOP-8715.3-009, Fire Safety.
- d. Employees shall:
 - (1) Comply with Center and NASA policies concerning not smoking in facilities or within 25 feet of air intakes, doors, operable windows, or posted non-smoking areas.
 - (2) Limit the length and frequency of smoking breaks to no more than 10 minutes every 4 hours (excluding the lunch break), so as not to detract from normal productivity and job performance.
 - (3) Inform non-employee visitors of the Center smoking policy when sponsoring a visitor.
