Pursuant to Title 11, Section 21 of the Federal Civilian Employee and Contractor Travel Expense Act of 1985 (PL 99-234), reimbursement for travel shall be in accordance with the provisions of FAR 31.205-46. Travel required in performance of work under this contract shall be in accordance with the Contractor's approved travel policy.

#### B. REIMBURSABLE INDIRECT CEILING RATES

Notwithstanding the terms of the contract clause entitled "Allowable Cost and Payment," the contractor shall not be reimbursed for costs in excess of the Overhead (O/H), General and Administrative (G&A), and any other indirect rate ceilings (per contractor fiscal year) shown below:

The indirect ceiling rates stated above will be examined at the conclusion of each contract period. If extreme and unforeseeable events have occurred and it is considered necessary and warranted, by the contracting officer, the indirect ceiling rates may be adjusted upward or downward for future periods. In no event will the contractor be allowed to recover indirect costs incurred in past years in excess of the ceiling applicable to each such year. Ceiling rates will not be increased without a clear and convincing demonstration that unforeseeable events have adversely affected the contractor's cost of performance under this contract.

The O/H rate calculations exclude general purpose training costs. The cost of general purpose training will not be subject to ceilings.

NBF is defined as costs for responding to NASA's Requests for Information, Sources Sought Synopsis, Draft and Formal Requests for Proposal accounted for within G&A expenses, and is limited to a maximum exclusion of \$4M. #### General and Administrative (G&A)

The base for application of G&A includes total value added costs including Host Administration overhead: Direct Labor (direct labor and fringe benefit dollars); processing operations overhead; overtime premium; other direct costs (travel, relocation and other miscellaneous value added costs); and Host Administration costs. Supplies, materials, equipment, subcontract or Interorganizational Work Authorization (IWA) costs are not included in the base for G&A application

#### D. PROVISIONAL INDIRECT BILLING RATES

- 4. Copies of all carriers' bills of lading will be available for review by the government on movements of household goods and personal effects that are the result of the relocation of the contractor employees when the total transportation costs are to be reimbursed by the government. Such requests must be made prior to the proposed move and in sufficient time for the Contracting Officer to make a decision.

#### H. PENSION PROGRAM REQUIREMENTS

Pursuant to NFS 1852.237-71, Pension Portability, included by reference in Section I of this contract, a clear description of the portable pension plan, including service, pay, liabilities, vesting, termination, and benefits from prior contracts will be inserted in this section, when applicable. The contractor does not have a portable pension plan and shall not be reimbursed for pension costs under this contract.

#### I. FRINGE BENEFITS

The contractor shall inform the contracting officer of all proposed changes in fringe benefits which may result in an increased cost to the contract as soon as practicable, but in any event, prior to such changes being implemented. Fringe benefits include, but are not limited to, such items as health insurance, life insurance, pension plans, retiree health care, savings plans, bonus plans, education assistance, and leave policies. Failure to comply with the terms of this clause may result in the disallowance of costs.

#### J. TRANSFER OF ACCRUED BENEFITS

The contractor will accept transfer of accrued sick leave hours and recognize the vacation leave accrual rates of incumbent personnel hired from the predecessor contract NAS10-11400, provided the employee had no break in service from the predecessor contract exceeding 60 days. The costs of the transferred sick leave hours will not be paid under this contract unless and until they are used.

#### ARTICLE B-6 SPECIAL PROVISIONS REGARDING CONTRACT ADJUSTMENTS

A. Revisions to milestones, missions, schedules, manifests and/or processing requirements may be made by the government, and shall be deemed within the scope of this contract. The government will consider a proposed equitable adjustment (increase or decrease) to the contract, when the estimated cost (exclusive of fee) of any single event exceeds the values listed below, unless the contractor's actions are a significant contributing factor causing a cost increase:

\$500,000 for CLIN 001A, Basic Period of Performance

\$600,000 for CLIN 001B, Option Period 1

\$700,000 for CLIN 001C, Option Period 2

However, the government will consider an adjustment to the contract, for estimated cost only (no fee) for those events equal to or less than the above thresholds. An

event is defined as the addition, substitution, or deletion of a payload for a scheduled mission once payload processing is commenced at KSC; a compression of a process flow, once commenced, to accelerate or avoid postponing a launch date; or the addition, substitution or elimination of a scheduled mission.

B. Equitable adjustments pursuant to any provision of this contract shall be subject to the limitations specified in Paragraph A above.

### ARTICLE B-8 PRICED OPTION FOR MULTIPLE ELEMENT INTEGRATED TEST 3 (CLIN 003)

The government may exercise an option for Multiple Element Integrated Test 3 (MEIT3) as delineated in Attachment J-2, Statement of Work for Priced Options. The government may exercise this MEIT3 option one time under CLIN 003, at any time during the basic contract period of performance (Oct 02 through Sep 06) by written notice to the contractor not later than 90 days prior to commencement of the option work. The price (cost and fee per table B-1G) in effect at the time the option is exercised shall cover the full price of performing the work, even if the duration of the test crosses fiscal years.

The government may exercise ground support equipment sustaining engineering options under CLIN 005C at any time during Option Period 2 (Oct 09 – Sep 12). Options may be exercised by written notice to the contractor not later than 90 days prior to commencement of the option work. The option to exercise CLIN 005B is contingent upon exercise of Option Period 1, CLIN 001B. The option to exercise CLIN 005C is contingent upon exercise of Option Period 2, CLIN 001C.
