SUBJECT: Determination Regarding Attendance by NASA Employees at the

40th Space Symposium and concurrent events, April 7 – 10, 2025

On April 7 – 10, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code will host the 40th Space Symposium in Colorado Springs, Colorado. Complementary Government registration will be covered under the authority of 31 U.S.C. §1353, Gifts of Travel From Non-Federal Sources, using NASA Form 1167. Invitations to additional events may have been provided by the sponsor. The Space Foundation is in control of the arrangements, invitations, and seating for most of the events taking place at the Broadmoor Hotel. Approximately 50-200 people are invited to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$100 per person. Attendance at this event will allow NASA employees to exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.
- 39. On April 9, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code, will hold a Space Technology Hall of Fame and Awards Luncheon from 12:15 p.m. to 2:00 p.m., in the Colorado Hall, at the Broadmoor Hotel. Approximately 400 people are invited to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$130 per person. Attendance at this event will allow NASA employees and a guest to exchange information regarding various NASA programs.
- 40. On April 9, 2025, Blue Origin will hold a reception at 5:00 p.m. to 7:00 p.m. in the Everest Cottage, at The Broadmoor Hotel. Approximately 200 250 people are invited to attend. This event provides for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$40.00 per person. Attendance at this event will allow NASA employees to exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.
- 41. On April 9, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code, will hold a Swigert Society Donor Reception from 5:00 p.m. to 6:30 p.m. in the Broadmoor Hotel. Approximately 70 people are invited to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$20 per person. Attendance at this event will allow NASA employees to exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.

- 42. On April 9, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code, and the Air & Space Force Association will hold a joint Executive Leadership Dinner: Ensuring U.S. Leadership in Space from 6:30 p.m. to 9:00 p.m. at the Broadmoor Fish House. Approximately 21 people are expected to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, and associations. The estimated cost of the event, including all food and beverages, is approximately \$255 per person. Attendance at this event will allow NASA attendees to exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.
- 43. On April 9, 2025, SpaceX will hold a SpaceX Symposium Reception at 8:00 p.m. to 11:00 p.m., PLAY at the Broadmoor Hotel. Approximately 100 people are invited to attend. The estimated cost of the event, including all food and beverages, is approximately \$50 per person. Attendance at this event will allow NASA employees to exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.
- 44. On April 10, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code, will hold a Space Workforce for Tomorrow Luncheon from 5:00 p.m. to 6:30 p.m. in the Broadmoor West: Rocky Mountain Ballroom. Approximately 250 people are invited to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$130 per person. Attendance at this event will allow NASA employees and a guest to exchange information regarding various NASA programs.
- 45. On April 10, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code, will hold a Closing Cocktail Reception from 5:30 p.m. to 6:30 p.m. in the Colorado Hall, at the Broadmoor Hotel. Approximately 600 people are invited to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$30 per person. Attendance at this event will allow NASA employees to exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.
- 46. On April 10, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code, will hold a Closing Dinner: Securing our Future from 7:00 p.m. to 9:00 p.m. at the International Center, at the Broadmoor Hotel. Approximately 350 people are invited to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$70 per person. Attendance at this event will allow NASA employees to

exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.

47. On April 10, 2025, the Space Foundation, a nonprofit organization under 501(c)(3) of the Internal Revenue Code, will hold a Celebration of New Generation Space Leaders from 9:00 p.m. to 12:30 a.m. at Colorado Hall at the Broadmoor Hotel. Approximately 350 people are invited to attend. This event provides an opportunity for informal discussion with people who have diverse views or interests and will include people from other federal agencies and the legislative branch, representatives from industry, academia, media, and foreign governments. The estimated cost of the event, including all food and beverages, is approximately \$70 per person. Attendance at this event will allow NASA employees to exchange information regarding various NASA programs. Due to space limitations for the event, guests are not invited.

I find that these events meet the requirements of a "widely attended gathering" as defined in 5 C.F.R. § 2635.204(g).² I further determine that there is an Agency interest in having NASA personnel attend these events because it will provide an opportunity for the invited persons to exchange ideas and views pertaining to NASA's policies, programs, and operations. Accordingly, NASA employees who do not have a significant role in a matter affecting the interests of the organization hosting the event as specified herein may accept an invitation for free attendance to that event, except as noted below. In those circumstances, I find that the Agency's interest in attendance outweighs any concern that the individual may be, or may appear to be, improperly influenced in the performance of their duties.³

Additionally, one guest of NASA employees may attend the events to which they have been invited, e.g., the opening and closing ceremonies (April 7 and April 10), Congressional Roundtable, Aerospace Corporation and Chairman's Reception (April 6), Corporate Partnership Dinner (April 8), National Security Space Association (April 8), Space Technology Hall of Fame and Awards Luncheon (April 9), and Space Workforce for Tomorrow (April 10). Also, NASA employees who have a significant role in any pending matter affecting the interests of any of the hosts of any event they wish to attend, such as procurement duties, program management, or negotiating or administering a Space Act Agreement, should seek a separate determination from their local ethics counselor as to whether they may accept the invitation.⁴

This widely attended gathering determination does not cover the receptions in hospitality suites that may occur during the 40th Space Symposium. These suites will be hosted by corporate sponsors. Most NASA employees who are invited may receive refreshments

provided in these suites under the exception to the gift rules that allows acceptance of gifts (including refreshments and tangible gift items) with an aggregate value of \$20 or less per event. Attendees are reminded that this \$20 gift exception at 5 C.F.R. § 2635.204(a), allows acceptance of no more than \$50 from one source in a calendar year.
